1. CERTIFICATION OF ORIGINALITY OF SUBMISSIONS

I hereby certify and warrant that any submissions sent from the above registered e-mail address(es) are my own original works and/or that I have the sufficient written legal right of ownership to grant permission and use of the material as set forth in this agreement. I accept full personal responsibility for any action taken to challenge the originality of my work of the legal rights by which I have included its use under the terms of this agreement.

2. GRANT OF LICENSE TO PUBLISH UNDER THE OPEN GAMING LICENSE

By signing this agreement, I am granting license for all submissions sent to the DnD Community Council and/or its representatives, agents, successors, and assigns for distribution under the Open Gaming License, specifically including the grant of the right to use, modify, reproduce, publish and distribute all portions of my submissions in any current or future DnD Community Council-sponsored publication. I understand that this gives the DnD Community Council the right to publish and distribute my submissions and that I cannot later revoke this right without the consent of the DnD Community Council. My work shall remain my own, and I shall the retain copyright rights thereof; this license does not transfer copyright rights but rather grants the DnD Community Council the right to publish my own copyrighted works.

3. STATEMENT OF UNDERSTANDING OF THE OPEN GAMING LICENSE

I have read and understand the Open Gaming License as prepared by Wizards of the Coast, and I hereby grant the DnD Community Council the right to publish my work under the terms of this license.
